YOUR EXCELLENCY:

The agreement between the Government of Your Excellency and the Government of Peru securing the services of a United States Naval Mission to my Country will expire on July 31, 1952. Under Paragraph 3 of the agreement it is stated that it's renewal should be effected six months prior to the date of expiration.

Upon instructions of my Government, I have the honor to inform Your Excellency that it is the desire of the Peruvian Government to renew the agreement, and in order to comply with the terms of Paragraph 3, it is hoped that the renewal, if agreeable to the United States Government, could be signed before January 31, 1952.

Accept, Your Excellency, the renewed assurances of my highest consideration.

I have the honor to acknowledge receipt of the Embassy's note No. 5-3-M/15 of January 18, 1952 requesting the renewal for a period of four years of the agreement entered into on July 30, [1] 1940 [2] and

extended on two occasions for a period of four years each by an exchange of notes dated January 31, February 9 and March 1, 1944 [¹] and January 12 and March 2, 1948 [²] respectively between the Governments of the United States of America and the Republic of Peru providing for the assignment of a United States Naval Mission to Peru.

I am pleased to inform you that the renewal of the Agreement for a period of four years effective July 31, 1952 is agreeable to the Government of the United States of America.
