The Ministry kindly asks for the possibility of mutual abolition of visa requrement for the holders of diplomatic and official passports also, starting with the date of your note in reply.

The Ministry of Foreign Affairs of the Republic of Macedonia presents its compliments to the Embassy of Peru in Belgrade and has the honor to acknowledge receipt of the Embassy's Note No.CM06/06 dated July 14 2006 regarding the abolition of visa requirements for bearers of diplomatic, official and special passports of Republic of Macedonia and Pery, with the following content:

"The Embassy of Peru expresses its conformity to the mutual abolition of visa requirement for bearers of diplomatic, official and special passports proposed by the Note No. 78-2687/2. Accordingly, no visa will be required for Peruvian citizen's bearers of valid diplomatic, official or special passports traveling to Macedonia for up to ninety days, as well as for Macedonian citizen's bearers of valid diplomatic, official or special passports traveling to Peru up to ninety days.

This Agreement will not restrict the right of the competent authorities of both countries to refuse without further explanations the entrance or permanence case those persons being considered as persona non grata. Should any disagreement arise from the implementation or interpretation of this agreement it will be settled through the diplomatic channels.

Any of the Parties can suspend totally or partially the application of this Agreement notifying the other Party its suspension, as well as the resuming of the Agreement.

This Agreement will be in force for an indefinite period and each party can terminate its validity at any time subject to the mutual written consent by both Parties and it will cease to operate sixty days after the receipt of the notice of termination".

The Ministry of Foreign Affairs of the Republic of Macedonia has the honor to inform that the Macedonian Party agrees with above mentioned proposal for concluding an Agreement for abolition of visa requirements for holders of diplomatic, official and special passports of Republic of Macedonia and Pery under the proposed terms.
